

Stonecom Contest Rules

Contest: Mom, Moe's & Me

Station: Lite Rock 95.9

Sponsor: Moe's Southwest Grill

Section One: How to Enter the Contest.

1. Thursday, October 20th, 2022, the contest will begin, for the chance to win a prize.
2. You must be 18 years of age or older to win.
3. The Prize is defined as a certificate worth up to but not exceeding \$70 to be used to purchase a meal for a family of 4 at Moe's Southwest Grill in Cookeville, TN.
4. Winners will be chosen from total entries received within allotted nomination times in the specified window of October 19th, 2022 – May 3rd, 2023.
5. Listen in to Lite Rock 95.9 on weekday mornings to hear the chance for your child to call in and nominate your family to receive this Moe's Southwest Grill certificate.

Section Two: Eligibility Restrictions

1. The contest is open to all Stonecom listeners who are legal United States citizens who reside in Stonecom listening area of Middle Tennessee.
2. Employees of the local businesses involved, Stonecom, its licensee, Stonecom, their subsidiaries, affiliated entities, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Middle Tennessee listening area and the members of their immediate families are ineligible to participate or win. Immediate family shall include spouse, parents, children, siblings, grandparents, grandchildren and any other person residing within the same household.

4. Only one winner or qualifier per family per household is permitted in any contest.

5. Winners will be contacted by a station representative on how to receive the prize.
6. The Stonecom Promotions Department reserves the right to make changes to the winner selection process without notice.
7. All contest decisions are final.
8. Must be present at time of call to win.
9. If unavailable to call, no Prize will be awarded.

10. If unavailable to call, Stonecom will select a new qualifier.
